



Yeovil Town Football Club – Executive Box Hire – Terms and Conditions

1. These terms and conditions (“**the Terms**”) are applicable to any booking for Executive Box Hire during the applicable season. The Terms shall be in place between Yeovil Town Football Club (“**the Club**”) and the Hiring Organisation/Individual (“**the Hirer**”).
2. Booking Confirmation: A booking is confirmed once full payment is received by the Club. Payment must be made at least 24 hours prior to the match day for which an executive box is booked or in the event of a season long booking at least 24 hours prior to the first matchday fixture of the season for which the hire is applicable.
3. Once the booking has been confirmed, this cannot be cancelled by the Hirer.
4. The Hirer cannot sub-let their executive box without the written consent of the Club. The Hirer or a nominated representative must be present at all fixtures for which the Hirer is utilising their box.
5. In the event of a match being postponed due to inclement weather, the Hirer shall retain their box for the re-arranged fixture.
6. The Club may cancel the booking with 3 days notice and will undertake to reschedule the booking for the next available fixture that the Hirer is available to attend.
7. Obligations of the Hirer:
 - a. The Hirer shall ensure that all guests comply with the code of conduct of the Club and the dress code required in respect of attendance in the Glovers Lounge;
 - b. The Hirer shall not make any alterations to the box without the consent of the Head of Stadium Operations.
8. Obligations of the Club:
 - a. The Club shall provide ten match-day tickets per match for which the executive box is booked;

9. Liability: The Club is not responsible for any loss, injury, or damage, however caused, provided that nothing shall exclude or limit the Club’s liability for death or personal injury caused by its negligence or any other liability which cannot be excluded or limited under applicable law.
10. Photography and Promotion: The Club may take photographs or recordings for promotional purposes. By accepting these terms, you give consent for the Club to use such images or footage in its promotional materials.
